- (c) to urge members and breeders to accept the standard of the breed as approved by the American Kennel Club as the only standard of excellence by which Irish Wolfhounds shall be judged;
- (d) to do all in its power to protect and advance the interests of the breed by encouraging sportsmanlike competition at dog shows and obedience trials;
- (e) to conduct sanctioned matches and specialty shows under the rules of the American Kennel Club.
